2	Roll Call	Kate Alder, Interim Dean, Continuing Education, MiraCosta College; Manuel Zapata, Director of Accountability and Special Programs, San Dieguito Union High School District. Special guest Neil Kelly with the AEBG State Chancellor's office (CCCCO).	
	Special Guest	Special guest Neil Kelly from the AEBG state office division of the state Chancellor's office: Kelly explained the reason for asking for program area expenses is to meet a federal requirement. The federal government required when we (AEBG) accepted the \$90M WIOA Title II Adult Literacy funding, that we show our state fund spending to prove we are not supplanting but are supplementing the federal dollars with local state funding. This requirement began this year, and will be required annually at the end of the year. It will meet the federal requirement for expenditure process; this is not a budget requirement.	
		Alder remarked that going forward, during our next round of three year planning, the Consortium will keep that in mind to support our structure. Kelly suggested beginning the three-year process now over the next six months as the new NOVA online system will be fully operational within next couple months. Kelly reminded Consortium to update older plan to new plan process. NOVA includes census data for Consortia for different levels and types of service: i.e., NOVA is designed to pull last year's student data reporting for this year to minimize additional hiring for data research analysts. Alder inquired whether that means there will not be any supplemental funding for the Consortia for this round of planning. Kelly confirmed do this out of current allocation. System designed for better ease and use of service. NOVA does not require new strategies.
