ISSUE: This item presents to the Board of Governors the programs recommended for final approval for participation in the California Community Colleges Baccalaureate Degree Pilot Program.

BACKGROUND: On September 28, 2014, Governor Jerry Brown signed SB 850 (Block) authorizing the Board of Governors, in consultation with the California State University (CSU) and University of California (UC), to establish a statewide Baccalaureate Degree Pilot Program at up to 15 California community colleges. To accomplish this objective, the Board of Governors was charged with developing a process for selection of the pilot programs.

On November 21, 2014, the Academic Affairs Division released the Baccalaureate Degree Pilot Program Application with a submission deadline of December 19, 2014. In response, the Chancellor’s Office received 34 applications. To review and rate these proposals, the Chancellor’s Office convened a group of approximately 30 individuals from a board range of perspectives, including representatives from community college districts, other institutions of higher education, and the California Department of Education. RECOMMENDATION: It is recommended that the Board take action to grant final approval to programs, as identified in this item, for participation in the California Community Colleges Baccalaureate Degree Pilot.

(Background Cont.) On January 20, 2015, the Board reviewed 15 proposals recommended by the Chancellor’s Office and granted them initial approval, pending final approval at the March meeting. Since then, the Academic Affairs Division has worked closely with the colleges to collect additional information, including further labor market data and analyses, for the Board’s review.

In addition, the Chancellor’s Office staff engaged in further consultation with colleagues at CSU and UC to review proposals for potential duplication with existing programs in those systems. Through this consultation, CSU indicated that nine of the proposals did not raise any concerns, four proposals raised some concerns that could be resolved with additional collaboration, and two proposals raised more significant concerns over duplication that led CSU to object (Interaction Design, Santa Monica College; Automotive Technology, Rio Honda College). See attached letter from CSU Chancellor White presenting these conclusions. In consultation, UC raised no concerns over duplication.

Subsequent to the January Board meeting, one of the applicant colleges, Crafton Hills Community College, withdrew its application for the Baccalaureate Degree Pilot program.

RECOMMENDED ACTION:

The Chancellor recommends that the Board grant final approval to the following programs:
